I/We hereby certify that:

1. The above statements are true to the best of my/our knowledge and belief;
2. I am/We are the applicant(s) applying for registration or I am/we are authorized to make this application on behalf of the applicant; and,
3. If the applicant is registered, the applicant undertakes to comply with the provisions of the *Waste Reduction and Recovery Act, Single-use Retail Bag Regulations*, and the following Terms and Conditions of registration:
 1. You shall, within 30 days at the end of each quarter, for the previous quarter for which single-use retail bags (SRB) were sold or distributed by you to retail stores in the Northwest Territories (NWT):
 - a) Submit quarterly reporting forms in the form and manner required by the Chief Environmental Protection Officer;
 - b) Make payment to the Chief Environmental Protection Officer for credit to the Environment Fund of the surcharges required by the Single-use Retail Bag Regulations; and
 - c) Submit to the Chief Environmental Protection Officer a list of NWT retail stores to which you have sold or distributed single-use retail bags.
 2. Goods and Services Tax for the single-use retail bag surcharge must be collected by the distributor for taxable products and remitted to Canada Revenue Agency.
 3. Upon request of the Chief Environmental Protection Officer, the distributor shall provide a copy of books of accounts detailing all monies collected and paid under these Regulations.
