1 Introduction

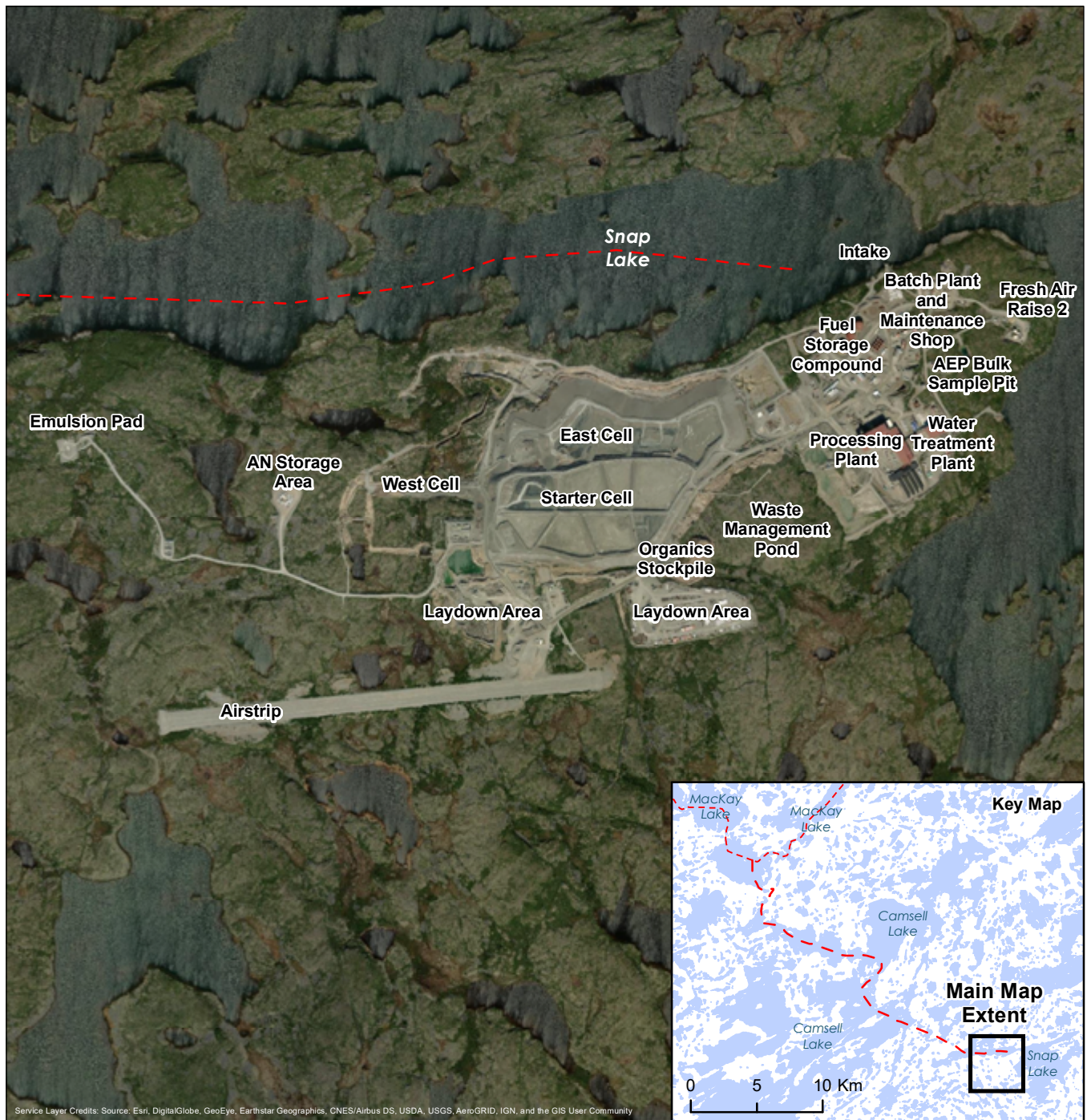
Figure 1.1 Location of Snap Lake Mine

Snap Lake Mine (the “Mine”) is an underground diamond mine located approximately 220 kilometres (km) northeast of Yellowknife (Figure 1.1). De Beers Canada Inc. (De Beers) operated the mine from 2008 to 2015. Mining activities were suspended in December 2015. Effective June 22, 2016, the Mine entered an extended Care and Maintenance (ECM) phase and in December 2017, De Beers announced the Mine would be preparing for final closure. A Final Closure and Reclamation Plan (FCRP), together with a renewal application for the Water Licence (MV2019L2-0004), was submitted to the Mackenzie Valley Land and Water Board (MVLWB) in March 2019. On May 21, 2020, the Water Licence for closure and post-closure was granted, effective June 14, 2020. The latest update of the FCRP was submitted to the MVLWB in July 2022, which received approval in December 2022 pending revisions. In a letter dated September 18, 2020, the Government of Northwest Territories (GNWT) Department of Environment and Natural Resources (ENR) informed De Beers that under Section 95 of the Wildlife Act, a Wildlife Management and Monitoring Plan (WMMP) for the closure and post-closure phase of the Snap Lake Mine is required. The WMMP would replace all previous submissions and authorized versions of the Wildlife Habitat Protection Plan and Wildlife Effects Monitoring Plans under the Snap Lake Environmental Agreement. Furthermore, the letter from ENR also indicated that the plan would fulfill the requirements of the Environmental Agreement (Section 6.2 and 6.3). De Beers submitted the WMMP on March 28, 2021, with a public review of the document coordinated by the GNWT. Following the review, WMMP Version 1.1. was submitted on December 3, 2021, incorporating the feedback from reviewers. Through further review, ENR requested eight additional revisions to the WMMP Version 1.1. These revisions were addressed in Version 1.2, which was conditionally approved on July 15, 2022.

1.1 Objectives

The 2022 Annual Wildlife Management and Monitoring Report (WWMR) has been prepared in accordance with the WMMP (De Beers 2021a) and Article 7.4 of the Environmental Agreement. The primary purpose of the annual WWMR is to evaluate accuracy of effects predictions (e.g., wildlife sensory disturbance) and to assess the effectiveness of mitigation measures implemented at the Mine to reduce potential effects on wildlife and wildlife habitat. The annual WWMR is also used to recommend any potential changes to wildlife monitoring components and/or protocols as described in the WMMP (De Beers 2021a).

The 2022 WWMR provides a summary of wildlife mitigation measures implemented at the Mine during Year 1 of Closure as well as wildlife monitoring results that included wildlife observations recorded during decommissioning/demolition activities of Mine infrastructure including the North Pile, water management system, airstrip, buildings and waste management areas. This report describes wildlife mitigation and monitoring that occurred at the Mine from January 1 to December 31, 2022 as summarized in Table 1.1.

A comprehensive analysis of mitigation and monitoring activities will be undertaken in the year after closure activities are complete (Year 1 of Post-Closure). A comprehensive analysis report is also anticipated in Year 6 of the Post-Closure period in accordance with the FCRP. The reports will provide a mechanism for determining the certainty of effects predictions, unanticipated ecological effects, and

effectiveness of mitigation policies, procedures, and actions. The reports will also be used to help assess the effectiveness and utility of various components of the WMMP. Using the principles of adaptive management, the assessment will be used to make recommendations regarding the intensity, frequency, and duration of recording of wildlife observations, and possible changes to the components included in the monitoring program.

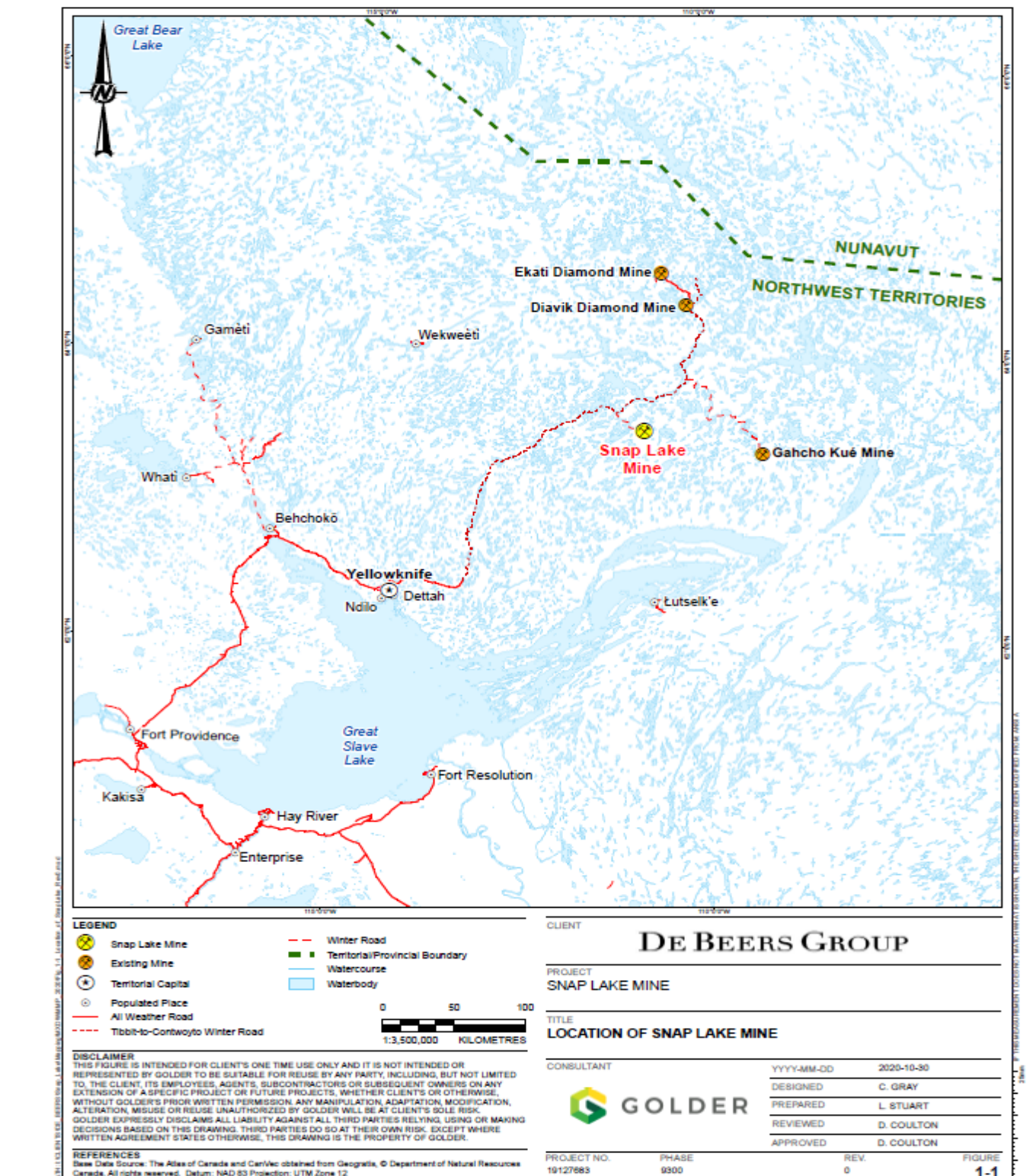

2 Wildlife Mitigation

2.1 Wildlife Species of Concern

As defined in the WMMP, wildlife species of concern include wildlife species at risk (endangered, threatened, special concern) under the federal *Species at Risk Act* (SARA) and/or the territorial *Species at Risk* (NWT) *Act*. In addition, species of concern includes those species identified by the Committee on the Status of Endangered Wildlife in Canada (COSEWIC) but not yet listed by SARA or the *Species at Risk* (NWT) *Act* (De Beers 2021a). Recent amendments to Schedule 1 of SARA include a change in conservation status for two wildlife species including the peregrine falcon (*Falco peregrinus anatum-tundrius*), which was delisted from special concern to not at risk and Harris's sparrow (*Zonotrichia querula*), which was added to Schedule 1 of SARA as special concern (GOC 2023).

Although all wildlife that interact with the Mine are recorded as part of the wildlife sightings log (see Section 3.3), the WMMP identified 11 species of concern that may interact with the Mine including two raptors, six migratory birds and three mammals (De Beers 2021a; Table 2.1).

Some of these species have potential to occur year-round while others such as barren-ground caribou, grizzly bear and migratory birds may interact with the Mine on a seasonal basis. The annual range of the Bathurst caribou herd overlaps the mine site where caribou can occur during spring and fall seasonal migration. The core winter range of the Bathurst caribou herd is located primarily south of the mine site and calving grounds are located near Bathurst Inlet (GNWT 2019).

The migratory bird nesting period for Nesting Zone C8 including species at risk extends from approximately May 1 to August 31 (ECCC 2018, GOC 2019). The nesting period for raptors including owls is approximately March to the end of September (GNWT-ENR 2019, 2020).

2.2 Vegetation Loss

Closure activities contribute to effects on wildlife and wildlife habitat through direct habitat loss from vegetation clearing. Mitigation measures to reduce direct effects on wildlife habitat from vegetation loss include reducing areas of new clearing to the extent practical. During closure in 2022, and in accordance with the FCRP, some new vegetation clearing was associated with constructing the South Perimeter Ditch. Infrastructure removal in other areas of the Mine were undertaken to prepare the site for grading and contouring. Additional mitigation measures will be implemented as described in the Final Revegetation Plan in future years of the Closure phase (De Beers 2020). Every five years (next in 2023), monitoring to assess change in wildlife habitat as observed through vegetation changes will be completed in accordance with the direction provided in the WMMP and the cumulative area of ELC units (vegetation types) reclaimed and revegetated will be included in the annual report once revegetation and reclamation are complete (De Beers 2021a).



2.3 Sensory Disturbance

Closure activities contribute to indirect effects on wildlife and wildlife habitat by influencing the quality of habitats adjacent to the physical footprint. Indirect effects are caused by sensory disturbances such as dust and noise.

During the winter of 2021/2022, occupancy was maintained in preparation for closure activities. Closure activities began on March 1, 2022, with site occupancy increasing from approximately 40 to approximately 110 persons in the summer. The mine site activity was reduced in mid-December with only about 10 staff members present. There were no periods of zero occupancy in 2022.

During Year 1 of Closure, activities that had potential to disturb wildlife included construction and operation of the Winter Access Road, demolition activities, blasting and excavation of passive water management facilities, site infill and grading, waste management and camp operations.

Earthworks activities commenced on May 20 with the excavation of the West Influent Storage Pond to design elevations. Earthworks activities were also conducted in the North Pile, South Perimeter Ditch, North Perimeter Ditch, East Influent Storage Pond (ISP), Laydown 1, West Cell Divider Dyke and the Quarry. New clearing and blasting was required to construct the South Perimeter Ditch. All perimeter sumps and the Water Management Pond were dewatered to facilitate earthworks. This included excavation of organic material and sediment from the Water Management Pond to construct the East ISP per design.

Crushing operations at Snap Lake began in June of 2022. Material was generated throughout 2022 based on the specifications for material needed for construction activities indicated by the project engineer of record. Transition, bedding, erosion protection and 150 mm rip rap material was produced and stockpiled at the crushing/screener location for use during construction activities.

An inventory of the various waste streams found on-site was compiled in 2022. An inventory was completed on available areas and several waste streams were identified. As decommissioning progressed, the waste materials were stored in the approved location at the former ammonium nitrate storage building.

Demolition of structures was extensive in 2022. In total, 42 structures, 3 x 12 million (M) litre (L) aboveground fuel storage tanks (ASTs) and six x 500,000 L ASTs were demolished for disposal. Structures remaining in December 2022 included maintenance and laydown buildings, 10 ML tank, 300,000 L AST tank farm and fuel systems, main camp and communications buildings. Modular power units, water and wastewater treatment plants and incinerators remained in place to support continued Mine closure activities in 2023.

As per the WMMP, the following mitigation measures were implemented (as necessary) during 2022 to reduce potential sensory disturbance to wildlife including:

- Dust suppression through regular road watering was applied when required, based on visual observations.



- Speed limits (30 km/hr) were enforced to reduce the production of dust and noise.
- Speed limits were reduced when caribou and other large wildlife were within 200 m of roads.
- Snow berms along the Winter Access Road were maintained at heights of less than 1.6 m to not hinder wildlife movement.
- A minimum flying altitude of 300 m above ground level was implemented (except during takeoff and landing) for cargo and passenger aircraft outside of the Mine site.
- Personnel were prohibited from using personal recreational vehicles.
- A pre-blasting search for large mammals was conducted in the area within 1 km of the blasting site. Blasting will be delayed when large mammals are present within the search area.

2.3.1 CARIBOU MITIGATION

In addition to the mitigation measures outlined above, the following caribou mitigation measures were implemented (as necessary) during 2022:

- All sightings of caribou were reported to the on-site Environment Department and immediately communicated to all vehicle operators; (see Wildlife Sightings Log in Appendix B).
- Caribou were not blocked from crossing Mine-related roads or the airstrip. When caribou were crossing or attempting to cross the winter or site roads, then traffic was required to stop and wait for them to cross (caribou have the right of way).
- Aircraft were notified to enter a holding pattern until the caribou completed their crossing of the airstrip.
- Caribou within 100 m of the airstrip, site service roads, or winter access roads were monitored.
- Caribou were only herded away from roads or the airstrip in specific circumstances, such as an emergency and the following scenarios:
 - There were less than 100 caribou on the airstrip within 15 minutes of flight arrival.
 - Caribou were on the road or airstrip at the time of an emergency that requires the use of the road or airstrip.
 - Caribou were within 100 m of the airstrip 15 minutes prior to aircraft arrivals or departures.
- When deterrent action is necessary, caribou were to be deterred from the airstrip by driving a truck down the strip, getting out of the vehicle, and making noise by yelling.
- All incidents involving interactions, use of deterrents or potential injury of caribou were documented and evaluated (see documented interactions in Table 3.3).

There were no interactions with caribou that required reporting to GNW-ENR in 2022.



2.4 Incidents and Mortalities

Closure activities can contribute to wildlife incidents including injury or mortality. As per the WMMP, the following mitigation measures were implemented (as necessary) during 2022 to reduce potential injury and mortality to wildlife:

- Employees and contractors were prohibited from hunting, trapping, harvesting and fishing.
- Personal use of recreational vehicles was not permitted.
- There was zero tolerance toward harassment of wildlife.
- Speed limits (maximum of 30 km/hr) on roads were enforced.
- Wildlife always had the right of way on roads.
- Speed limits were reduced when caribou and other large wildlife were within 200 m of roads and Environment staff on site were notified.
- When vehicles were stopped at night due to wildlife presence, bright headlights were to be turned off, low beams or driving lights were to remain on.
- Drivers were warned with radio and signage when wildlife were moving through an area.
- Pre-demolition nest sweeps were conducted by qualified persons during the breeding season (May 4 to August 17) (Section 3.2, Appendix A).
- Surveys for wildlife and raptor nests were conducted prior to commencing demolition activities.
- Unoccupied nests were reported to Environment and Climate Change Canada (ECCC) to determine the appropriate course of action prior to demolition activities (Section 3.2, Appendix A).
- Deterrents were used to discourage birds and raptors from nesting on Mine infrastructure (Section 3.2, Appendix A).
- Bank swallows were discouraged from establishing colonies on sites or features by contouring slopes to less than 70 degrees.
- Active bird nests and inactive raptor nests were not removed.
- A species-specific and disturbance-specific buffer zone was used around active nests found at site, based on consultation with ECCC.
- When needed, wildlife deterrent actions were performed by designated individuals (such as the Environment staff or security staff).
- Training and education was provided to on-site personnel and visitors about wildlife awareness, waste management and wildlife safety.
- Waste management was conducted in accordance with the Management Plan. Corrective actions were communicated to site personnel.
- Designated indoor areas were identified for lunch and coffee breaks
- Food waste and non-food waste were separated through the use of designated garbage cans to prevent food waste from entering the landfill.



- Food waste and other attractants were incinerated regularly to reduce holding time and odours.
- Food waste, fuel waste and other potential animal attractants were stored inside buildings or bear-proof containers prior to incineration or transportation off-site for disposal.
- Hazardous material was stored securely, isolated and sent off site for recycling or disposal at an appropriate facility.
- The landfill was inspected and regularly covered.
- Measures to prevent, respond and remediate spills were implemented in accordance with the Spill Contingency Plan.

2.4.1 BIRD NEST DETERRENT, PROTECTION AND REMOVAL MEASURES

Closure activities in 2022 had potential to interact with migratory bird nests that are protected under federal and/or territorial legislation. Deterrent measures to reduce the potential for birds to nest on Mine infrastructure scheduled for decommissioning/demolition were implemented following the *Nesting Deterrence Procedures for Migratory Birds at the Snap Lake Mine* Operating Procedure (EP-DOP 015 of the WMMP), as applicable to the species observed on site. Inactive bird nests located on existing Mine infrastructure (i.e., buildings) were also removed with approval of ECCC, to reduce potential interactions outside of the breeding bird season.

2.4.1.1 Methods

Data collected regarding inactive nests were recorded in the appropriate EP-DOP 015 data collection forms and reported to ECCC to obtain approval to remove inactive nests prior to the breeding bird season. Active nests were managed in accordance with the EP-DOP 015 and the WMMP (De Beers 2021a). Specifically, pre-demolition nest searches of mine infrastructure were completed to identify active bird nests during the peak breeding period for migratory birds (mid-May to late June). Active bird nests were monitored until they were no longer occupied and subsequently removed (Section 3.2, Appendix A). Incidental wildlife sightings were also recorded (Section 3.3, Appendix B).

Where active nests were identified, activity setbacks were established and nests were monitored in accordance with guidance provided by ECCC. This included establishing no-entry into doorways and setback distances for equipment and personnel. For cliff swallows this included a setback of approximately 5 m. For bank swallow, surveyed setbacks were established to 50 m, and were demarcated using stakes, pylons and flagging. All active nests were monitored until they were no longer occupied (i.e., birds had fledged). Unoccupied and inactive nests were removed following consultation with the Canadian Wildlife Service (CWS). Unoccupied cavities in soil/granular material were destroyed in late 2022 through regrading of slopes as part of approved closure designs, and to discourage nest prospecting in 2023.



2.4.1.2 Results

Overall, bird deterrents were limited to dismantling roofs and overhangs as practical, and installing physical barriers such as tarps and netting across openings and overhangs of buildings scheduled to be demolished in 2022. During 2022, 8 partly constructed common raven nests and 3 unknown grass nests found on mine infrastructure were removed prior to the breeding bird season. In addition, 57 cliff swallow nests were removed from mine infrastructure (e.g., buildings, overhangs) at 7 locations prior to the breeding bird season. A summary of bird nest removal activities and deterrent measures implemented during 2022 are provided in Appendix A, Table A-1).



3 Wildlife Monitoring

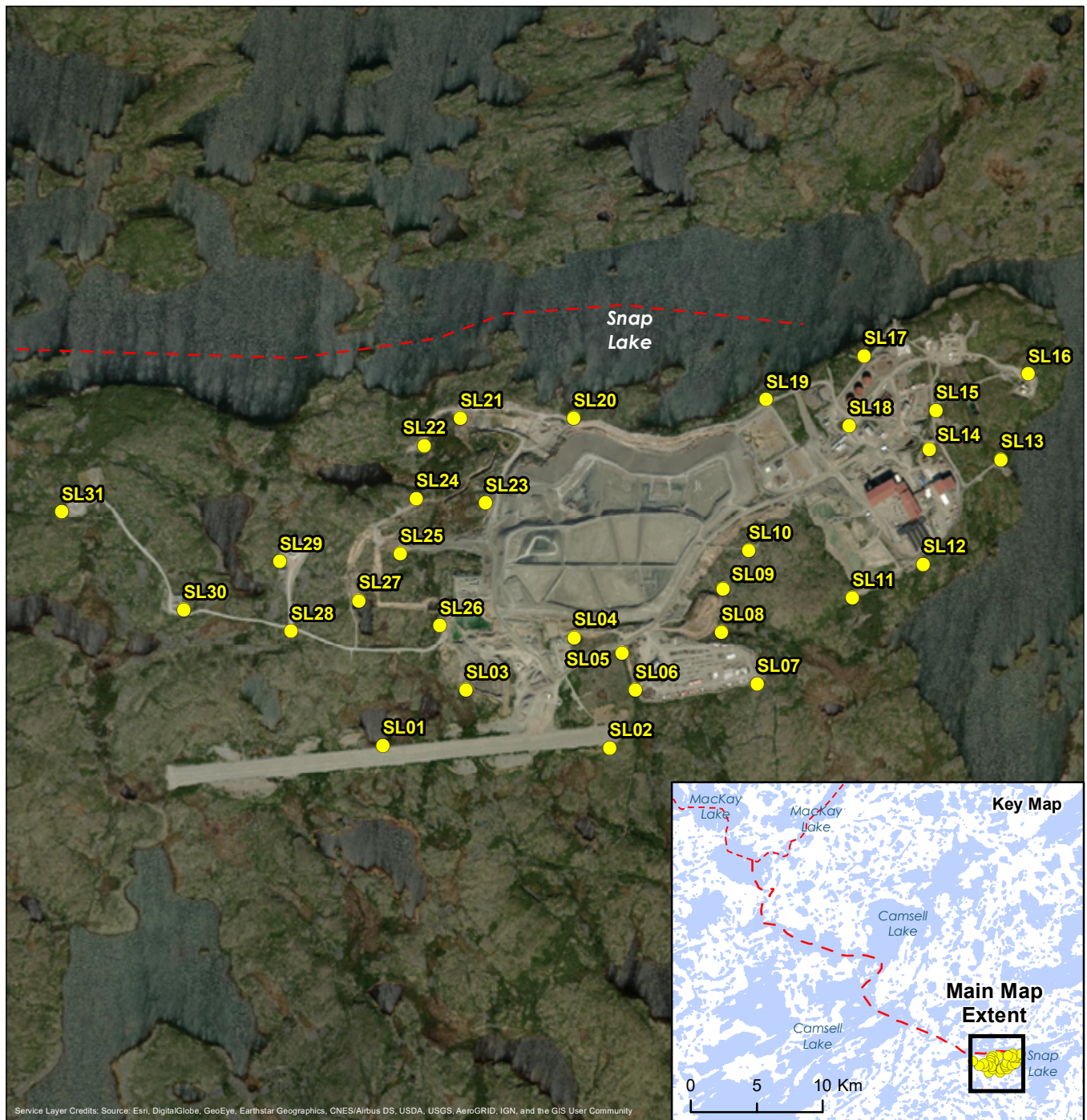
During 2022, wildlife monitoring included a record of incidental wildlife sightings, environmental inspections, waste inspections, nesting and nest deterrence monitoring, wildlife incident management as well as site selection to support future remote camera monitoring at the mine site.

3.1 Caribou Monitoring

The Bathurst caribou will be monitored using GPS and satellite collar data to determine potential changes in distribution relative to the mine site using ZOI monitoring (De Beers 2021a). The GNWT-ENR will provide the collar data and De Beers will complete an analysis of caribou habitat use collar using the ZOI guidelines at the end of the closure period anticipated to be in 2024 (end of Closure activities). The analysis will include all data extending from 1996 to end of closure, and once during post-closure (1996 to post-closure), depending on availability of collar data in the Mine study area. Therefore, ZOI monitoring is not included in the scope of this 2022 WMMR.

In addition to ZOI monitoring, remote camera monitoring is required to be implemented during periods of zero occupancy at the Mine site and during post-closure. In 2022, the remote camera station locations were selected and posts were installed for future camera placement (see Figure 3.1).

3.2 Bird Nest Monitoring

In 2022, active nests monitored throughout the breeding bird season included several cliff swallow colonies located on Mine buildings, and bank swallow cavities located on the North Pile and several other soil banks.

3.2.1 CLIFF SWALLOW

3.2.1.1 Methods

Active cliff swallow colonies identified on Mine buildings were monitored during the breeding season until the nests were no longer occupied (i.e., birds had fledged). Each nest within a colony was monitored for 5 minutes using binoculars, approximately bi-weekly during the breeding season, with frequency increased to every three days towards the end of the breeding season. The number of individuals (adults, young), behaviour (carrying food, flying in/out, guarding, etc.) were recorded.

3.2.1.2 Results

Three cliff swallow colonies were monitored on July 4 and August 9-14, 2022 to determine occupancy and number of active nests. Nests were removed once they had been vacated (no activity) for a period of three days. Total observation time varied from 30 minutes to 1.5 hours depending on the number of active nests within each colony.

3.2.2 BANK SWALLOW

In 2021, De Beers received approval to reshape slopes of the North Pile to discourage bank swallow nesting. All slopes of the North Pile were inspected in early April 2022 and confirmed to be less than 70 degree slope. Most slopes were closer to 50 degrees. In June, several new cavities were observed by Environment staff at the Mine at historical nesting locations within the North Pile. ECCC was notified of active bank swallow cavities on May 26. Monitoring of 13 locations of cavities continued from May 26 until July 25.

Stantec provided a memo to the CWS on July 28, 2022 outlining the approach to protecting and monitoring bank swallow nests at the Mine site, and the results of monitoring, which showed likely failure of all active nests monitored in 2022 (see Section 3.2.2).

3.2.2.1 Methods

Thirteen bank swallow nesting cavity sites were monitored at the Mine site during 2022 (Figure 3.2). Each site was visited regularly (e.g., once per week) during the breeding season to determine nest status and number of birds present. Nesting sites were observed for approximately 30 minutes at each location. Monitoring occurred more frequently (e.g., once per day or two) to establish when nests were no longer active.

3.2.2.2 Results

The results of the bank swallow monitoring indicated most of the nesting sites (cavities) were eventually depredated (46.1%) during the breeding season, 3 had collapsed (23.1%) due to slope erosion and 4 nesting sites (30.8%) were deemed inactive where bank swallows were observed but did not enter existing burrows (i.e., possible prospecting to evaluate potential nesting sites). A summary of bank swallow monitoring results is provided in Table 3.1.

Based on Stantec's observations between July 20 and July 25, 2022, it was concluded that there were no active bank swallow nests in the North Pile or Water Management Pond areas (see above) and there is minimal risk in proceeding with decommissioning activities in these areas. Prior to commencing works that will impact former nesting sites, final pre-activity nest sweeps were completed as outlined in the WMMP. It was confirmed that no active nests were present. Setbacks were removed and closure activities proceeded.

3.3 Wildlife Sightings Log

Environment staff, mine employees and contractors recorded incidental wildlife observations at the Mine site from March 1, 2022 to December 31, 2022 by (see Appendix B). A total of 49 wildlife species/groups were observed in 2022, including 13 mammals and 36 bird species (Table 3.2). Seven species at risk were observed including barren-ground caribou, grizzly bear, wolverine, bank swallow, barn swallow, Harris's sparrow and yellow warbler (*Setophaga petechia*). Barren-ground caribou, common raven (*Corvus corax*) and arctic hare (*Lepus arcticus*) were the most frequently observed wildlife species followed by passerine birds and gulls (Table 3.2). Barren-ground caribou were observed on 174 occasions. Caribou were observed throughout the Mine but were most frequently observed near the airstrip, meteorological station (Met Station), Waste Management Pond and Snap Lake. Group size varied from 1 to 87 individuals with larger group sizes observed on Snap Lake. Overall, the wildlife species incidentally observed at the Mine site during 2022 were similar to the wildlife species/groups observed during 2019 (De Beers 2021b).

3.4 Wildlife Incidents

As defined in the WMMP (De Beers 2021), an incident is any wildlife interaction that requires a response by Mine personnel requiring action such as the use of deterrents, or result in property damage, injury or death of wildlife.

Seven wildlife incidents were recorded in 2022, including three incidents at generators where four American kestrels were found dead (Table 3.3). A detailed description of wildlife incidents and responses is provided in Table 3.3.

4 Adaptive Management

Wildlife (birds and mammals) were observed at the Mine in 2022 mostly without incident or injury to wildlife, which indicates mitigation measures implemented to reduce potential effects of decommissioning and closure activities on wildlife have been effective. The bird mortalities (e.g., American kestrels) identified during decommissioning of three generators (Gen 2,5 and 6) occurred prior to closure activities and prior to 2022; and therefore, no further mitigation is recommended to reduce potential bird mortalities associated with generators as all mine generators and exhaust hoods have been decommissioned and removed.

Bird deterrents will continue to be a priority to reduce potential interactions with Mine infrastructure; however, most infrastructure at the Mine has now been demolished. Bank swallow mitigation will also be enhanced to deter potential nesting activities on granular slopes by maintaining slopes less than 70 degrees, or less if possible. Overall, De Beers will continue to implement the existing mitigation measures and wildlife monitoring as provided in the WMMP (De Beers 2021); results from 2022 have indicated that mitigations are working as intended and no changes are recommended at this time.


