Update on the Status of the Review of the Wildlife Management and Monitoring Plan for the Ekati Diamond Mine

In a letter dated June 23, 2021, the Department of Environment and Climate Change (ECC), formerly known as Environment and Natural Resources (ENR), informed Arctic Canadian Diamond Company Ltd. (Arctic) that they were required under Section 95 of the *Wildlife Act* to submit a Wildlife Management and Monitoring Plan (WMMP) for the Ekati Diamond Mine. Arctic submitted a WMMP on November 17, 2022, and a public review of the document was initiated through Wek'èezhì Land and Water Board via their Online Review System. Arctic hosted a WMMP focused workshop February 3 and 10, and received final stakeholder comments on February 17, 2023. ECC, received the Ekati WMMP March 13, 2023.

Through that process four parties provided comments - Deninu Kùé First Nation (DKFN), Tłı̨chǫ Government, Independent Environmental Monitoring Agency (IEMA) and Environment and Climate Change Canada (ECCC). Arctic provided responses to the initial reviewers comments on February 3, 2023, and incorporated additional feedback into a final version submitted to ECC for approval March 13, 2023.

This letter is to notify Arctic that ECC is currently reviewing the Ekati WMMP document and will be providing ECC's decision shortly. ECC recognizes the [WMMP Process and Content Guidelines](#) states ECC will provide a decision to whether the Minister approves or provisionally approves within 30 days and post a decision to the registry. However, ECC is extending this timeline to ensure a comprehensive and in-depth review is completed.
